**TRUSTEES' REPORT**  
**FOR THE YEAR ENDED 31 AUGUST 2018**

The Trustees present their annual report together with the financial statements and auditor's report of the charitable company for the 1 September 2017 to 31 August 2018. The Annual report serves the purposes of both a Trustees' report, and a Directors' report under company law.

Since the academy qualifies as small under section 383, the strategic report required of medium and large companies under The Companies Act 2006 (Strategic Report and Director's Report) Regulations 2013 is not required.

The academy also trades under the name Southend YMCA Community School.

**Structure, governance and management**

**a. CONSTITUTION**

The academy is a charitable company limited by guarantee and an exempt charity.

The charitable company's Memorandum of Association is the primary governing document of the academy trust.

The Trustees of South Essex Community School Limited are also the directors of the charitable company for the purpose of company law.

The charitable company is known as Southend YMCA Community School.

Details of the Trustees who served during the are included in the Reference and administrative details on page 1.

**b. MEMBERS' LIABILITY**

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

**c. METHOD OF RECRUITMENT AND APPOINTMENT OR ELECTION OF TRUSTEES**

The management of the academy is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association.

The number of governors shall not be less than three but (unless otherwise determined by ordinary resolution) shall not be subject to any maximum. The academy trust shall have the following governors (details have been extracted from the articles of association):

- up to eight governors as appointed by the Southend YMCA;
- up to two parent governors who are parents of registered pupils at the alternative provision academy or, where it is not reasonably practical to do so, a person who is the parent of a child of compulsory school age;
- the principal;
- the chief executive officer of Southend YMCA; and
- one staff governor as appointed by the members through such process as they may determine.

Staff and parent governors are recruited by nomination and election by all staff and the parent body. Community trustees are recruited by invitation from the chair or headteacher or persons known to the academy who are able to benefit the academy by their knowledge and expertise.

**d. POLICIES AND PROCEDURES ADOPTED FOR THE INDUCTION AND TRAINING OF TRUSTEES**

All governors are expected to undertake training as appropriate to their work at the school and new governors are provided with an induction programme as required. Governor training is reviewed on a regular basis at governors meetings.

The academy trust conducts a skill audit of prospective governors and uses a safer recruitment process to appoint governors in order to safeguard young people.

The school has increased the mandatory training to now include a further module on General Data Protection Regulations in-line with statutory requirements.

**e. ORGANISATIONAL STRUCTURE**

The school has sustained the capacity numbers of students and the number of commissioning schools has steadily increased; widening the number of schools to include Essex schools and Virtual Schools across the country. The number of pupils that are Looked After has increased as has the support roles within the school structure.

The School has established a good reputation within the community and among its peers within the education sector, both locally and nationally, for delivering 'Good' alternative education. The school is represented at the borough at a strategic level and contributes to shaping the service delivery across the borough. Including Social Care, Virtual School Board, Education Board.

The introduction of School based policies and procedures has enabled the recruitment of qualified and experienced teaching, learning and support staff, broadening and enriching the curriculum and building the capacity and capability of the staff team.

The new pay and performance structure was implemented from April 2016 has seen an increase in experienced qualified teachers taking up posts with Southend YMCA Community School over 2017 - 2018.

The school has reviewed the key posts and extended the Senior Leadership Team to include a full time Business Manager. The School secured this post in March 2018 with responsibilities for overseeing Health & Safety, Premises Management, Personnel and Business Administration. This role has been crucial in terms of developing the quality of our provision while meeting our legal requirements and obligations.

The school has employed external consultants to assist in developing and improving the quality of provision; this includes a School Improvement Partner and H&S Consultants adding both capacity and technical knowledge.

**f. PAY POLICY FOR KEY MANAGEMENT PERSONNEL**

Pay for senior leaders is reviewed annually by the governors pay committee following the outcome of performance reviews.

**g. CONNECTED ORGANISATIONS, INCLUDING RELATED PARTY RELATIONSHIPS**

Southend YMCA is the children's charity providing services to vulnerable young people in Southend. These range from Housing, mentoring through to support services. Southend YMCA Community School was borne out of the work of the main charity. Southend YMCA Community School accounts are consolidated with the main charity, both organisations have separate auditors. The work between the Children's charity and the school has been reviewed and the Partnership Agreement between the two organisations has ceased. The Children's Charity is currently considering ways to contribute to the work of the school, this is still under review.

**a. OBJECTS AND AIMS**

Alternative Provision is for pupils who cannot attend mainstream school for a variety of reasons, such as school exclusion, behaviour issues, short- or long-term illness, school refusal or teenage pregnancy. It is our mission and vision to ensure all children receive a high-quality education.

**b. OBJECTIVES, STRATEGIES AND ACTIVITIES**

**Our Vision**

Southend YMCA Community School's vision is to 'Stand in the Gap' by offering an alternative education free school to improve the education offer for young people that cannot be educated within the mainstream education setting. Our school aims to address the needs and aspirations of young people and help to transform their lives through education.

**Demographics of Southend**

Southend YMCA Community School is located in the heart of Southend. Southend has an estimated population close to 181,800, Southend is one of the largest conurbations in the East of England. Our town is changing. We are gradually becoming more ethnically diverse and the number of older people is increasing. Deprivation in Southend is higher than the England average and the regional average. In 2017-18 the number of economically inactive people stood at 18.1% compared to the national average of 21.6%. Workless households for Southend stood at 13.5% compared to the national average of 14.5%. With 11.9% of the Southend population claiming out of work benefits, slightly higher than the national average of 11% for working age benefit claimants. In 2015, 25.8% (45,840 people) of Southend residents lived within areas classified as being in the 20% most deprived in England.

The majority (79.4%) of Southend's children have a good standard of living that promotes their long term wellbeing, but more needs to be done to improve the life chances of those living in poverty. The level of child poverty in Southend-on-Sea (20.6%) is worse than the England average (18.6%) and the regional average (15.4%). Our data identifies that year on year we attract a higher percentage of students eligible for pupil premium, 2017/18 45% are eligible for pupil premium.

**Our work**

Southend YMCA Community School is an alternative education provider serving the schools within Southend, Essex and Thurrock. We pride ourselves on providing a holistic education programme addressing both academic and social skills. Aiding our students by equipping them with the skills to successfully enter the next stage of their life post compulsory school age.

Statistics show that nationally pupils at the end of key stage 4 (14-16 compulsory school age) in alternative provision including pupil referral units achieve lower than their peers within the mainstream school setting. Pupils at Southend YMCA Community School achieve significantly higher than their peers in alternative provision. 100% of all Southend YMCA Community School pupils are entered for a GCSE programmes including Maths and English. Our results clearly show our performance outcomes far exceed our peers within the Alternative education setting.

We have made significant strides forward since the Ofsted inspection (June 2015). The school is on a continual improvement cycle and has seen the capacity of school double since opening.

**Southend YMCA Community School Ethos**

Our school ethos is one of acceptance, tolerance and encouragement with academic progress at the heart of our work. As practitioners we are proud to say that our alternative approach, which is often unique, centres upon behaviour modification. We do not condone poor behaviour, but are guided by an aspirational philosophy aiming to eliminate unacceptable and often anti-social behaviour. It is evident that our daily approach to working with these vulnerable and often marginalised young people centres on guidance and role modelling rather than punishment and rigid fixed boundaries. This approach does not totally eliminate but significantly reduces such negative behaviours.

Staff demonstrate daily their passion for inclusivity. Students often arrive at the school disillusioned with the education system. Their behaviours often exhibit a disregard for authority coupled with negative experiences of adults involved with them and their families. Building positive relationships with our students is pivotal in breaking

down their previously construed understanding of education. Our pursuit is to engage our students and aid their desire to learn and form better relationships with those in authority.

Staff within the school demonstrate an unquenchable thirst for changing the lives of our students. This is demonstrable through the unconditional regard for students, modelling suitable behaviours and engineering a less chaotic/harsh, more forgiving and acceptable environment conducive to absorbing information and learning. We aim to equip our students with the skills, knowledge and aspiration to integrate within mainstream society post compulsory education age.

We take a therapeutic approach to working with these often challenging students. Staff work hard not to over punish the students for behaviours attributable to the challenging and often chaotic lives they are born into; despite these remarkable life experiences many students accept the additional support offered through the school to raise self-esteem and self-belief; the school work in close partnership with a number of support agencies including; social care, police, attendance officer, counselling, youth offending, drug and alcohol teams through to the emotional wellbeing and mental health services.

Our curriculum is designed to support the students in maximising progress and attainment. Students undertake a broad, rich and deep curriculum which provides both the academic rigour of GCSE national qualifications fused with a life skills programme to develop them as good citizens; humanising teachers and those within authority and not simply teaching to test. Students are encouraged to develop their community spirit through community projects within the areas they reside.

We seek to retain the outcomes akin to mainstream education, with the ability to withstand the rigorous and often inflexible measures enshrined within inspection regimes. The success of our school is deep rooted in our approach, 'Sisu' meaning 'Never giving up' we try not to squeeze our students into a conventional mould that often describes a mainstream education experience.

Southend YMCA Community School has implemented a range of new systems that are more in line with the mainstream school day; timetable, lesson duration, movement around the school. The staff team reflect a wealth of experience and knowledge to support the students' needs both academically and socially. The curriculum provides opportunities for the students to achieve 8 GCSE's to aid positive progression post compulsory school age. All qualifications offered will be externally recognised with QCF status.

A key feature of the curriculum is embedding the personal and social development work through the academic curriculum. The number of students who are exhibiting mental health issues has significantly risen; the school is working with students that have mental health professionals supporting them. Many of the students have complex issues that often pertain to the family environment, they often live at elevated risk, have wider challenges to cope with outside that of a regular child their age. The school has implemented a range of support programmes to assist the students in building self-esteem and resilience. It is also noted that many of the students have also accessed our Anger Management programme aiding wider coping strategies.

#### **c. PUBLIC BENEFIT**

The governors confirm that they have referred to the guidance contained in the Charity Commission general guidance on public benefit when reviewing the academy trust's objectives and aims and in planning future activities for the year. The governors consider that the academy trust's aims are demonstrably to the public benefit.

The curriculum offer has significantly widened with the GCSE offer increasing year on year. With academic

results showing an upward trajectory of pupils gaining QRF qualifications similar to their peers within the mainstream education setting. Our latest results for 2017/18 GCSE show the following;

- 95.64% of students gained at least 1 GCSE (1-9)
- 91.30% of students gained at least Maths or English (1-9)
- 69.56% of students gained both Maths and English (1-9)
- 74% of students gained at least 1 GCSE grade C

**b. GOING CONCERN**

After making appropriate enquiries, the board of trustees has a reasonable expectation that the academy has adequate resources to continue in operational existence for the foreseeable future. For this reason it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Accounting Policies.

**Financial review**

**a. RESERVES POLICY**

It is the policy of the Academy trust to maintain a level of reserves that is sufficient to meet its future obligations. The finance committee are to review and implement a revised policy and propose the utilisation of the reserves funds.

The school is currently having a number of surveys undertaken in relation to the building; the school is in dispute with the building Company McEvoy's with the support of the EFSA.

**b. PRINCIPAL RISKS AND UNCERTAINTIES**

The Academy Trust has a comprehensive Risk Register which is reviewed regularly. Falling pupil numbers would impact on funding streams for the Academy, making a deficit budget a possibility and affecting long term viability. Consequently pupil forecasts are monitored carefully and appropriate responsive action is taken. Pupil numbers is regularly discussed at each board meeting.

**c. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES**

The academy trust's system of internal financial control is based on a framework of regular management information and administrative procedures: these systems reflect the segregation of duties and a clear system of delegation and accountability. Comprehensive budgeting and monitoring systems with an annual budget and monthly financial reports which are reviewed and agreed by the board of trustees at the Finance sub committee and then ratified at the full governing body meetings; these include reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes, setting targets to measure financial and other performance, clearly defined purchasing guidelines, delegation of authority and segregation of duties through to identification and management of risks. The board of trustees has continued to purchase specific internal audit function through the Southend Borough Council to work with the Business Manager to carry out internal checks.

Internal control is an annual controls check carried out by the Finance Team at Southend Borough Council, they carry out rigorous testing on all aspects of day to day finance and check that the school is adhering to the academies handbook. The findings of the audit along with recommendations is compiled and a report is produced and presented to the board of directors. The recommendations/audit process allows the school tighter control through rigorous processes and procedures aiding a more robust approach to financial management in school.

**Fundraising**

**Pay and performance**

While the school recognises that regular teacher pay and conditions are not adhered to, the pay and performance scheme is significantly aligned with this compared with previous terms and conditions; this was reflected within new contracts issued at the start of academic year 2017/18. Pay and performance was reviewed and qualified teaching staff were awarded a 5% increase at the end of academic year 2017/18.

**Quality of provision**

Southend YMCA Community School is working with South Essex Teaching School Alliance to improve the quality of our provision and ensure we are OFSTED ready. This work is supported by an external consultant who acts as our School Improvement Partner.

**International CPD and research project**

Erasmus+ is the European Union programme for education, training, youth and sport. The Department for Education oversees Erasmus+ in the UK. The programme is managed by the UK National Agency which is a partnership between the British Council and Ecorys UK.

Southend YMCA Community School is part of a wider project with five countries working in partnership to undertake research specifically focussing upon Special Educational Needs. Our school is funded for activities from September 2018 to August 2020 with approximately £16k funding to support this research.

Our project "Raising Aspirations for Social Inclusion" (RASI) was implemented in order to increase SEN students' integration into society by improving the quality of the education they receive.

The main objective is the exchange of good practices in leading, managing, teaching and supporting students with Special Educational Needs (SEN). Participants will develop, test and evaluate innovative methods, activities and strategies which will aid and stimulate opportunities for SEN education both in terms of academic and social skills development. The vehicle for the International learning centres on partner case studies presented at the host country training events.

The project aims to develop the quality of teaching and to improve students' motivation by increasing their self-esteem and helping them to experience success in a school environment where the focus often lies on academic skills/attainment.

The participation in this project is expected to bring long-lasting positive effects on each school and its culture. Teachers will be encouraged to share ideas, compare their experiences transnationally and to integrate good practices and methods into daily activities. Each partner school has formed a project team which includes the principal, the coordinator and 2-3 teachers or experts in teaching SEN.

Each school has chosen four specific areas/issues they would like to improve through this project. These issues are developed over the two year lifespan, specific time is allocated to focus upon each area. Each area or issue is introduced and discussed in detail within the international short-term staff training events (six) during a two-year period. Every event is named covering the content of the chosen issues and will be attended by chosen representatives from each partner school.

The school is currently in dispute with the building company assigned by the EFA to undertake the original building works who developed the school in 2013. The ESFA are supporting the school with this dispute and we anticipate building works to be undertaken within the next financial year.

**FUNDS HELD AS CUSTODIAN**

The trust did not hold any funds as custodian at the year end.

**SCOPE OF RESPONSIBILITY**

As trustees, we acknowledge we have overall responsibility for ensuring that South Essex Community School Limited has an effective and appropriate system of control, financial and otherwise. **Governance Reviews**

Governance arrangements has been a key focus this academic year. The membership of the board has been under review and restructured to include Full Governing Body Meetings and two further Sub-Committees; Pupil Welfare and Teaching and Learning, HR Finance and Premises. Our Board has increased to include a Parent Governor.

The membership of the board has been reviewed and the arrangements between the YMCA Charity and the School has been redefined. The outcome of this work has led to the removal of the Deed of Agreement and a commitment to update the Memorandum and Articles in line with the model articles produced by the Department for Education by the end of the 2018. The recruitment of trustees has enabled the school to restructure the meetings supported with sub committees.

**REVIEW OF VALUE FOR MONEY**

As Accounting Officer, the Principal has responsibility for ensuring that the academy delivers good value in the use of public resources. The Accounting Officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The Accounting Officer considers how the academy's use of its resources has provided good value for money during each academic year, and reports to the board of trustees where value for money can be improved, including the use of benchmarking data where appropriate. The Accounting Officer for the academy has delivered improved value for money during the year by:

Southend YMCA Community School provides an informative and effective Impartial Information Advice and Guidance (IAG) service through the Connexions Service. The cost of this service is vastly reduced as a result of the students being dual registered. This is also applicable to the school nursing service.

While our school places are largely funded through the General Annual Grant, the school relies on the commissioned places for the top up funding. With commissioned places reviewed annually, funding and sustainability is a key focus in terms of risk management. With the fragility of one year contracts the School has employed 8 members of our staff team are currently employed through Reed Recruitment services.

The School has an exceptional highly trained Business Manager who is constantly seeking to reduce costs and gain value for money. We have demonstrated this from terminating our contract with Tempus and managing this in house with Blakes Contractors who complete the regulatory building works. The Business Manager works closely with the procurement team at Southend Borough Council to ensure that the school secures large contracts at low rates by requesting the school is on the same pricing framework as Southend Borough Council. The advantage of this is that the Southend YMCA Community School can access very competitive rates that would not ordinarily be offered to us as an Academy. The risks are lower for the school under these umbrella contracts.

**THE PURPOSE OF THE SYSTEM OF INTERNAL CONTROL**

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives; it can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an ongoing process designed to identify and prioritise the risks to the achievement of academy policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in South Essex Community School Limited for the year 1 September 2017 to 31 August 2018 and up to the date of approval of the annual report and financial statements.

**CAPACITY TO HANDLE RISK**

The board of trustees has reviewed the key risks to which the academy is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The board of trustees is of the view that there is a formal ongoing process for identifying, evaluating and managing the academy's significant risks, that has been in place for the year 1 September 2017 to 31 August 2018 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the board of trustees.

**THE RISK AND CONTROL FRAMEWORK**

The academy's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the board of trustees;
- regular reviews by the Trustees of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes;
- setting targets to measure financial and other performance;
- clearly defined purchasing (asset purchase or capital investment) guidelines.
- delegation of authority and segregation of duties;
- identification and management of risks.

The board of trustees has considered the need for a specific internal audit function and has decided to appoint Southend Finance Team as internal auditor.

The internal auditor's role includes giving advice on financial matters and performing a range of checks on the academy's financial systems. In particular the checks carried out in the current period included:

On a yearly basis, the auditor reports to the board of trustees through the audit committee on the operation of the systems of control and on the discharge of the board of trustees' financial responsibilities.

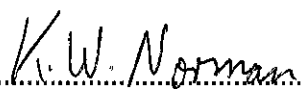
**REVIEW OF EFFECTIVENESS**

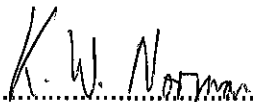

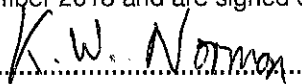

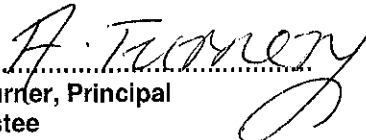

**1. ACCOUNTING POLICIES**

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgments and key sources of estimation uncertainty, is set out below.

**1.1 Basis of preparation of financial statements**

The financial statements of the academy trust, which is a public benefit entity under FRS 102, have been prepared under the historical cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2017 to 2018 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

South Essex Community School Limited constitutes a public benefit entity as defined by FRS 102.

**1.2 Fund accounting**

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the academy at the discretion of the Trustees.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

**1.3 Income**

All income is recognised once the academy has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Grants are included in the Statement of financial activities incorporating income and expenditure account on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the Statement of financial activities incorporating income and expenditure account in the year for which it is receivable and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended. Unspent amounts of capital grant are reflected in the balance in the restricted fixed asset fund.

Sponsorship income provided to the academy which amounts to a donation is recognised in the Statement of financial activities incorporating income and expenditure account in the period in which it is receivable, where receipt is probable and it is measurable.

Donations are recognised on a receivable basis where receipt is probable and the amount can be reliably measured.

Other income, including the hire of facilities, is recognised in the period in which it is receivable and to the extent the goods have been provided or on completion of the service.

**1.4 Expenditure**

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on charitable activities are costs incurred on the academy's educational operations, including support costs and those costs relating to the governance of the academy appointed to charitable activities.

All expenditure is inclusive of irrecoverable VAT.

**1.5 Going concern**

The Trustees assess whether the use of going concern is appropriate, i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the academy to continue as a going concern. The Trustees make this assessment in respect of a period of at least one year from the date of authorisation for issue of the financial statements and have concluded that the academy trust has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the academy trust's ability to continue as a going concern, thus they continue to adopt the going concern basis of accounting in preparing the financial statements

**1.6 Tangible fixed assets and depreciation**

All assets costing more than £1,000 are capitalised and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding requiring the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the Statement of financial activities incorporating income and expenditure account and carried forward in the Balance sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the Statement of financial activities incorporating income and expenditure account. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

Depreciation is provided on all tangible fixed assets other than freehold land, at rates calculated to write off the cost of these assets, less their estimated residual value, over their expected useful lives on the following bases:

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of financial activities incorporating income and expenditure account.

**1.7 Debtors**

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

**1.8 Cash at Bank and in hand**

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

**1.9 Liabilities and provisions**

Liabilities and provisions are recognised when there is an obligation at the Balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the academy anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide. Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised within interest payable and similar charges.

**1.10 Financial instruments**

The academy only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the academy and their measurement basis are as follows:

*Financial assets* - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost as detailed in note 16. Prepayments are not financial instruments. Amounts due to the academy's wholly owned subsidiary are held at face value less any impairment. Cash at bank is classified as a basic financial instrument and is measured at face value.

*Financial liabilities* - trade creditors, accruals and other creditors are financial instruments, and are measured at amortised costs as detailed in note 17. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instruments. Amounts due to the academy's wholly owned subsidiary are held at face value less any impairment.

**1.11 Taxation**

The academy is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the academy is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

**1.12 Pensions**

Retirement benefits to employees of the academy trust are provided by the Teachers' Pension Scheme ("TPS") and the Local Governments Pension Scheme ("LGPS"). These are defined benefit schemes.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the academy in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective unit credit method. As stated in note 23, the TPS is a multi-employer scheme and there is insufficient information available to use defined benefit accounting. The TPS is therefore treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

The LGPS is a funded scheme and the assets are held separately from those of the academy trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each Balance sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the Statement of financial activities incorporating income and expenditure account and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

**1.13 Critical accounting estimates and areas of judgment**

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions:

The academy trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost (income) for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 23, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2016 has been used by the actuary in valuing the pensions liability at 31 August 2018. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

**Teachers' Pension Scheme**

**Introduction**

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pensions Regulations (2010) and, from 1 April 2014, by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies and, from 1 January 2007, automatic for teachers in part-time employment following appointment or a change of contract, although they are able to opt out.

The TPS is an unfunded scheme and members contribute on a 'pay as you go' basis – these contributions along with those made by employers are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

**Valuation of the Teachers' Pension Scheme**

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2012 and in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014. The valuation report was published by the Department for Education on 9 June 2014. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 16.48% of pensionable pay, including a 0.08% employer administration charge.
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £191,500 million, and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £176,600 million giving a notional past service deficit of £14,900 million
- an employer cost cap of 10.9% of pensionable pay will be applied to future valuations
- the assumed real rate of return is 3.0% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.75%. The assumed nominal rate of return is 5.06%.

The TPS valuation for 2012 determined an employer rate of 16.4%, which was payable from September 2015. The next valuation of the TPS is currently underway based on April 2016 data, whereupon the employer contribution rate is expected to be reassessed and will be payable from 1 April 2019.

The employer's pension costs paid to TPS in the period amounted to £40,601 (2017 - £37,406).

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The trust has set out above the information available on the scheme.

**Local Government Pension Scheme**

The LGPS is a funded defined benefit scheme, with assets held in separate trustee-administered funds. The total contribution made for the year ended 31 August 2018 was £21,000 (2017 - £12,000), of which employer's contributions totalled £16,000 (2017 - £9,000) and employees' contributions totalled £5,000 (2017 - £3,000). The agreed contribution rates for future years are 17.1% for employers and 5.5% to
